# 1. End User License Agreement for the Security Algorithm Accelerator

This end user license agreement ("License") is a legal agreement between you (a single individual), or the company or organisation (a single legal entity) that you represent and have the legal authority to bind ("You"), and Arm relating to use of the Security Algorithm Accelerator . By clicking "I Agree" or by installing or otherwise using the Arm Technology (defined below) you indicate that you agree to be bound by all of the terms and conditions of this License.

## DEFINITIONS

"Arm" means Arm Limited whose registered office is situated at 110 Fulbourn Road, Cambridge CB1 9NJ, England and/or any member of Arm's group of companies.

"Arm Compliant Product" means an integrated circuit incorporating the Arm Technology and the corresponding Arm Processor.

"Arm Processor" means the applicable Arm based processor which corresponds with the Arm Technology as set out at <http://developer.arm.com/security-algorithm-accelerators>. "Arm Technology" means the Security Algorithm Accelerator technology licensed and delivered to You subject to the terms and conditions of this License.

"Intellectual Property" means any patents, patent rights, trademarks, service marks, registered designs, topography or semiconductor mask work rights, applications for any of the foregoing, copyright, unregistered design right and any other similar protected rights in any country and to the extent recognised by any relevant jurisdiction as intellectual property, trade secrets, know-how and confidential information.
